

NOTIFICATION

Whereas, Pimpri Chinchwad Municipal Corporation is empowered to remove, tow away and recover, removal & administration charges from the motor vehicles causing obstruction to the traffic and/or parked in “No Parking” zones under [section 208](#), Mumbai Municipal Corporation Act, 1949 and whereas the Corporation is always engaged in other important civic duties, and whereas, due to paucity of manpower and infrastructure the Corporation is unable to discharge its powers effectively and whereas, increasing vehicular population and regularly occurring traffic snarls it has become imperative to take stern action and whereas, the General Body has accorded its approval to delegate the powers to traffic police for taking action under section 208. Mumbai Municipal Corporation Act, 1949 against all types of commercial vehicles and recover removal & administration charges from them, I Asheesh Sharma, IAS, Commissioner, Pimpri Chinchwad Municipal Corporation do hereby order as under:

ORDER

1. That the powers to take action against all types of Commercial Vehicles causing obstruction to traffic, parked in “No Parking” zones and moving unauthorisedly in BRTS lane and recover removal & administration charges from them as laid down, under section 208 of Mumbai Municipal Corporation Act. 1949 are hereby delegated to City Traffic Police
2. That the removal & administration charges imposed/recovered from erring motorists shall be recovered/imposed by the traffic officers of the rank of Police Sub Inspector and above only.
3. That the removal & administration charges shall be recovered from the erring drivers/owners of all types of commercial vehicles as under:

S. No.	Type of Vehicle	Amount of fine
1)	Heavy vehicles trucks, buses	5000/-
2)	Light vehicles up to 10 ton capacity	2500/-
3)	Cars, jeeps etc	2000/-
4)	Six seater, three seater rickshaw Three wheeler tempo	1500/-
5)	Other machinery, road roller	3000/-
6)	Two wheeler, motorcycles	1000/-

4. That the powers delegated for taking under section 208, Mumbai Municipal Corporation Act, 1949 shall be subject to terms and conditions annexed hereto.
5. That this order shall commence in force w. e. from 27 /08/2009 and shall remain in force till further orders.

What is Section 208 of BMC Act 1949:

The Bombay Provincial municipal Corporation Act, 1949

Section 208: - Power to prohibit use of streets for certain kinds of traffic:

(1) It shall be lawful for the Commissioner with the sanction of the corporation to

- (a) prohibit vehicular traffic in any particular public street vesting in the corporation so as to prevent danger, obstruction or inconvenience to the public by fixing up posts at both ends of such street or portion of such street;
- (b) prohibit in respect of all public streets, the transit of any vehicle of such form, construction, weight or size or laden with such heavy or unwieldy objects as may be deemed likely to cause injury to others, roadways or any construction thereon, or risk or obstruction to other vehicles to pedestrians along or over such street or streets, except under such condition as to time, mode of traction or locomotion, use of appliances for protection of the roadway, number of lights and assistants, and other general precautions and the payment of special charges as may be specified by the commissioner generally or specially in each case.

(2) Notices of such prohibitions as are imposed under sub-section(1) shall be posted up in conspicuous places at or near both ends of the public streets or portions thereof to which they relate, unless such prohibitions apply generally to all public streets.

प्रस्तावात नमुद प्रमाणे मनपा हद्दीमध्ये पे अँड पार्क योजना रावविणेस तसेच शहरातील नियोजित वी.आर.टी. मार्गातील अनाधिकृतपणे संचलन करणारे व शहरातील इतर रस्त्यावरील नो पार्किंग झोन मध्ये उभे राहणारे आणि वाहतुकीस अडथळा ठरणारे वाहनांवर दंडात्मक कारवाई करणेस आणि अशा कारवाईमधून मिळणारे शुल्कातून ५० % रक्कम वाहतुक पोलिसांना लागणारे अत्यावश्यक साहित्य खरेदी करणेसाठी वापरणेस परवानगी देणेस मान्यता देणेची शिफारस करणेत आली आहे. प्रस्तावात नमुद प्रमाणे हद्दीमध्ये पे अँड पार्क योजना रावविणेस तसेच शहरातील नियोजित वी.आर.टी. मार्गातील अनाधिकृतपणे

संचलन करणारे व शहरातील इतर रस्त्यावरील नो पार्किंग झोनमध्ये उभे राहणारे आणि वाहतुकीस अडथळा ठरणारे वाहनांवर दंडात्मक कारवाई करण्यास आणि अशा कारवाई मधून फक्त सार्वजनिक वाहन (commercial vehicle of all types) यांच्याकडून दंडात्मक कारवाई करून दंड वसूल करण्यात यावा. उर्वरित मुळ प्रस्तावा प्रमाणे कारवाई करण्यात यावी. तसेच सर्व पार्किंगच्या जागा ताब्यात घ्याव्यात व पार्किंगची सुविधा विना मोबदला उपलब्ध करण्यात यावी तसेच P-१ व P-२ प्रमाणे पार्किंगची सोय करण्यात यावी. फक्त (commercial) गाड्यांकडूनच दंड वसूल करण्यात यावा अशी मान्यता देणेत येत आहे.
